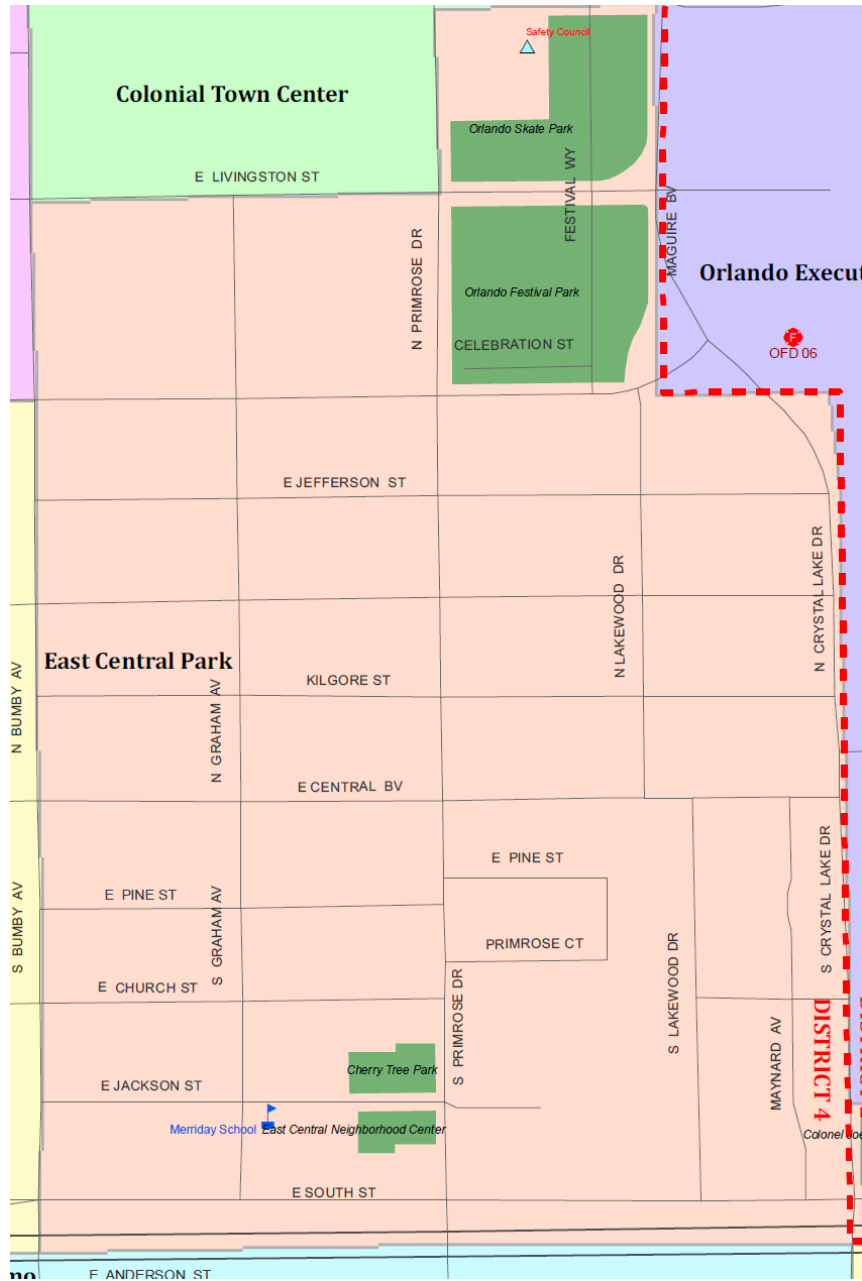


East Central Park

Often time citizens are unaware of what is going on in their particular neighborhood. This information is an attempt to help keep the community informed of police presence within your designated neighborhood. The map below reflects the boundaries used to compile the statistics for the East Central Park neighborhood.



The time period for this report is August 01, 2013 thru August 31, 2013.

Calls for Service represent the number of times that the Orlando Police Department has received a call for an issue in the associated neighborhood. Note: There could be multiple calls from citizens for the same incident. Reports occur when the police have documented a crime, suspected crime, or informational report for other reasons. Sometimes one crime can have multiple criminal elements.

During the month of August 2013, OPD responded to 172 Calls for Service. Of the 172 Calls for Service, OPD documented 23 incidences in 23 reports to wit:

- 3 Drugs/Narcotics: 2 Arrests, 1 Filed with State Attorney
