

The time period for this report is February 01, 2013 thru February 28, 2013.

Calls for Service represent the number of times that the Orlando Police Department has received a call for an issue in the associated neighborhood. Note: There could be multiple calls from citizens for the same incident. Reports occur when the police have documented a crime, suspected crime, or informational report for other reasons. Sometimes one crime can have multiple criminal elements. During the **month of February 2013**, OPD responded to **324 Calls for Service**. Of the 324 Calls for Service, OPD documented 56 incidences in 55 reports to wit:
