## Are you eligible?

### Major qualifying factors, you must have:

- Worked during the past year and earned income
- A valid Social Security number
- Joint tax-filing status (if married)
- U.S. citizenship or resident alien status all year, or be a nonresident alien married to a U.S. citizen or resident alien and file a joint return.

### Your income in 2008 must be less than:

#### If you are SINGLE...

- \$12,880 if you have no qualifying children
- \$33,995 if you have one qualifying child
- \$38,646 if you have more than one qualifying child

#### If you are MARRIED filing jointly...

- \$15,880 if you have no qualifying children
- \$36,995 if you have one qualifying child
- \$41,646 if you have more than one qualifying child

### Items you need to prepare your tax return:

- All forms, W-2s, and 1099s
- Information for other income
- Information for all deductions/credits
- A copy of last year's tax return (if you have a copy)
- Proof of account for direct deposit of refund (e.g., voided check)
- Social Security cards for you, dependents and/or spouse
- Photo identification for yourself and your spouse

## ¿Desea saber si califica?

### Entre otros factores que se necesitan para reunir los requisitos, usted tiene que:

- Haber trabajado y devengado ingresos durante el pasado año
- Tener un número de Seguro Social válido
- Si es casado, deberá presentar la declaración conjunta
- Deberá ser ciudadano de los Estados Unidos o extranjero residente durante todo el año, o ser un extranjero no residente casado con un ciudadano americano o extranjero residente y presentar una declaración conjunta

### Además, su ingreso de 2008 deberá ser menor de:

#### Si es SOLTERO...

- \$12,880 si no tiene un hijo calificado
- \$33,995 si tiene un hijo calificado
- \$38,646 si tiene más de un hijo calificado

#### Si usted es CASADO y presenta la declaración conjunta...

- \$15,880 si no tiene un hijo calificado
- \$36,995 si tiene un hijo calificado
- \$41,646 si tiene más de un hijo calificado

### Información que necesita traer consigo para preparar su planilla de impuestos:

- Todos los formularios, incluyendo W-2 y 1099
- Información sobre otros ingresos
- Información sobre todas las deducciones y créditos tributarios
- Copia de la planilla de impuestos del año anterior (si la tiene)
- Prueba de su cuenta bancaria para depósito directo o reembolso (cheque cancelado)
- Su tarjeta de Seguro Social, las de sus dependientes y/o de su cónyuge
- Su identificación con foto y la de su cónyuge
