1. PUBLIC COMMENT

2. BUYOUT MANAGER DISCUSSION - LEVINE, LEICHTMAN CAPITAL PARTNERS

Ms. Laudeman noted the Police Pension Board has allocated \$10 million to the private equity allocation for the vintage year 2017 and the Firefighters' Pension Board has allocated \$8 million for vintage year 2017. She then turned the meeting over to Mr. Stronkowsky of NEPC. He stated NEPC is recommending Levine, Leichtman Capital Partners, Inc., (LLCP) as a buyout manager for the private equity allocation (vintage year 2017) and asked Ms. Mendenhall to provide information about LLCP's background and strategy.

Ms. Laudeman asked if the members would like to interview LLCP and if there were any questions. Some discussion ensued.

A MOTION TO HIRE LEVINE, LEICHTMAN CAPITAL PARTNERS, INC. AS A BUYOUT MANAGER FOR THE EQUITY ALLOCATION AND TO BRING THEM IN FOR A DISCUSSION was made by Ms. Botts and seconded by Mr. Fleury; MOTION CARRIED UNANIMOUSLY.

A MOTION TO INVEST \$8 MILLION WITH LEVINE, LEICHTMAN CAPITAL PARTNERS, INC., IN THEIR SIXTH FUND was made by Chairman Zabin and seconded by Mr. Franklin; MOTION CARRIED UNANIMOUSLY.
