Any person desiring to appeal a recommended action of the Board must observe the NOTICE below and file an appeal with the recording secretary prior to 5 p.m. on **May 14, 2002** in order to schedule an appearance before a Hearing Officer in accordance with the provisions of Article XXXII of the City Code. **CAUTION:** Untimely filing of an appeal shall result in an automatic denial of the appeal. All Board approvals are also subject to the approval of all appropriate City Departments. [Persons with disabilities needing assistance to participate in any of these proceedings should contact the recording secretary 24 hours in advance of the meeting.]

**GENERAL RULES OF ORDER:** The Board is pleased to hear all non-repetitive relevant comments. However, since a general time limit of 5 minutes is allotted to the proponents/opponents of an issue, large groups are asked to name a spokesperson. When you are recognized, state your name and address, and speak directly to the microphone. **ROBERTS RULES OF ORDER** govern the conduct of the meeting. **NOTICE:** All appeals are subject to SNYDER requirements and are entitled to a de novo (new) hearing before an independent Hearing Officer. There is a \$250 fee for this appeal. Any person who desires to appeal any decision at this meeting would need a record of the proceedings and for this purpose may need to ensure that verbatim record of the proceedings is made which includes the testimony and evidence upon which the appeal is made.

Please note that applicants must comply with all other applicable requirements of the Land Development Code, including any additional review requirements and shall receive all necessary permits before initiating development.

Introduction of Members

**I. FIRST ITEM OF BUSINESS:** Approval of the April 2, 2002, Board of Zoning Adjustment minutes.

**II. SECOND ITEM OF BUSINESS: CONSENT AGENDA**

- 1. VAR2002-00037, JOHN THRAILKILL,** variance to the minimum rear yard setback to permit an existing accessory structure to remain at 539 W. Harvard Street (**DISTRICT 3**).

**STAFF RECOMMENDATION:** Approval of the request based on the finding that the proposed variance meets the six standards for zoning variance approval subject to the following conditions:

- The accessory structure shall not be converted into a dwelling unit.

2. **VAR2002-00046, COECUA CORPORATION**, variance to the maximum allowable sign area to permit a pole sign at 1468 Semoran Boulevard (**DISTRICT 2**).

**STAFF RECOMMENDATION:** Approval of the request based on the finding that the proposed variance approval meets the six standards for zoning variance approval subject to the following conditions:

- The sign shall be a ground-mounted sign; pole signs are prohibited.
- The sign shall not exceed 6 feet in height.
- No part of the sign shall extend beyond the building restriction line or encroach into the public right-of-way.

3. **VAR2002-00047, PAUL & JOANNE SANGIOVANNI**, variance to the minimum required side yard setback to permit an addition in line with the existing structure at 1102 Wilkinson Street (**DISTRICT 4**).

**STAFF RECOMMENDATION:** Approval of the request based on the finding that the proposed variance meets the six standards for zoning variance approval.

### **III. THIRD ITEM OF BUSINESS: REGULAR AGENDA**

4. **VAR2002-00044, VICTOR R. PECHACEK**, variance to the front yard setback to permit an addition (carport) at 1430 Manchester Street (**DISTRICT 3**).
5. **VAR2002-00045, AVERY PARKER/KEVIN RENZI**, variance to the minimum required rear yard setback to permit a garage addition to the principal structure at 802 S. Lake Davis Drive (**DISTRICT 1**).
6. **VAR2002-00048, ROBERT BRYAN**, variances to the rear and side yard setback requirements to allow a partially constructed accessory structure less than 12 ft. in height (skateboard ramp) to remain at 1214 Belleaire Circle (**DISTRICT 3**).
7. **VAR2002-00049, ROBERT COLLINS/LARRY SCHNAPER**, variance to the minimum required side yard setback to permit a wooden deck to remain at 405 E. Livingston Street (**DISTRICT 4**).

## **STANDARDS FOR ZONING VARIANCE APPROVAL**

Section 65.383 of the Land Development Code, stipulates specific standards for the approval of variances which read as follows: No application for a Zoning Variance shall be approved unless the Board of Zoning Adjustment finds that all of the following standards are met:

1. Special Conditions and Circumstances - Special conditions and circumstances exist which are peculiar to the land, structure, or building involved and which are not applicable to other lands, structures or buildings in the same zoning district. Zoning violations or nonconformities on neighboring properties shall not constitute grounds for approval of any proposed Zoning Variance.
2. Not Self-Created - The special conditions and circumstances do not result from the actions of the applicant. A self-created hardship shall not justify a Zoning Variance; i. e., when the applicant himself by his own conduct creates the hardship, which he alleges to exist, he is not entitled to relief.
3. No Special Privilege Conferred - Approval of the Zoning Variance requested would not confer on the applicant any special privilege that is denied by this Chapter to other lands, buildings, or structures in the same zoning district.
4. Deprivation of Rights - Literal interpretation of the provisions contained in the Chapter would deprive the applicant of rights commonly enjoyed by other properties in the same zoning district under the terms of this Chapter and would work unnecessary and undue hardship on the applicant. Financial loss or business competition shall not constitute grounds for approval of any variance. Purchase of property with intent to develop in violation of the restrictions of this Chapter shall not constitute grounds for approval.
5. Minimum Possible Variance - The Zoning Variance approved is the minimum variance that will make possible the reasonable use of the land, building or structure.
6. Purpose and Intent - Approval of the Zoning Variance will be in harmony with the purpose and intent of this Chapter and such Zoning Variance will not be injurious to the neighborhood or otherwise detrimental to the public welfare.
