Branch of service, rank, pay grade, type discharge or status, dates, length of service, addresses, disciplinary actions, security clearances, Veteran's Preference information

DRIVER'S LICENSE

Information, driving history, citations (past 5 years), accidents, suspensions, revocations, including all dates, violations

PERSONAL REFERENCES

Six personal references, addresses, phone number, fax number

NEIGHBOR INFORMATION

Three current neighbors, addresses (neighbor names may be blank)

PERSONAL CHARACTER BACKGROUND

Legal judgments, bankruptcies, surety bonds, complete criminal history (including juvenile), employment terminations, illegal drug history (including dates), relatives employed by City of Orlando, other last names (including dates, details), alcohol questions

PREVIOUS LAW ENFORCEMENT APPLICATIONS

Dates, addresses, status

REMARKS

Career plans, objectives
